Dear Colleague,

Few things move as fast as the speed of technology, and the mental health professions are certainly no exception. My mission with Person-Centered Tech is to help my colleagues learn what they need to be able to approach technology courageously, ethically and safely.

HIPAA laws were updated in January of this year, and I've been doing a lot of research on how they impact the mental health field. While there are new concerns to be aware of, the basic fact hasn't changed: technology is available to us in mental health practice both legally and ethically. We need only take proper precautions for safety and collaborate with clients – like we do with anything in our work.

The online world is no exception to that rule. The vast majority of people under 30 use a social network. Facebook has over 500 million users. I personally don't know anyone who doesn't have at least one email address. Our clients are sitting at the digital table and would like us to be there with them, holding our healthy therapeutic boundaries all the while.



I not only grew up geek, but I worked as a professional Web developer for over 7 years before joining the mental health profession. I act as Technology Committee Chair for the Oregon Counseling Association and am a member of the Ethics Committee. I am also a member of the Zur Institute's Advisory Board, and am an adjunct faculty member at the Portland State University Department of Counselor Education.

Roy Huggins earned his BA from Grinnell College with a major in Music in 1999. In an interesting twist of fate, his studies in music lead straight in to professional Web development as co-owner and manager of TUG Internet Specialists, a Web development and consulting firm in Grinnell, IA. After a couple years, the firm broke up and Roy moved in to a solo career, where he not only built websites and Internet-based software systems, but also consulted with clients on marketing concerns both practical and ethical, Web-based business plans and Web presence expansion.
